#### THE HUMBLE PETITION OF

#### THE PETITIONERS ABOVE NAMED

#### **MOST RESPECTFULLY SHOWETH:**

1. The petitioners herein are residents of Endosulfan affected area in Kasargod district in Kerala. The children of the petitioners are affected by the spread of a toxic pesticide called Endosulfan and they are included in the list of "Endosulfan victims". It is submitted that the first petitioner's daughter, Ms. Archana P is suffering from Cardio Vascular problems on being impacted by the pesticide. True copy of the beneficiary identification Card is produced herewith and marked as ANNEXURE - P1 (Page 16). Due to the same reason, The second petitioner's son, Master Afsal is suffering from high hormonal imbalance. Once in every 60 days, an injection costing Rs.18,500 has to be taken for saving the life of the child. The true copy of the Sneha Santhwanam card of Afsal is produced herewith and marked as ANNEXURE - P2 (Page 17). The 3<sup>rd</sup> petitioner's daughter, Ms. Nisha is having 70% permanent severe disability due to mental retardation. The true copy of the disability certificate dated 11.06.2004 issued by the Health Services Department, Government of Kerala is produced herewith and marked as **ANNEXURE** -P3 (Page 18). The true copy of the Sneha Santhwanam card of Ms. Nisha is produced herewith and marked as ANNEXURE - P4 (Page 19). The 4<sup>th</sup> petitioner's daughter, Ms. Vijaya Lakshmi is suffering from low motor disability. The true copy of the medical report is produced herewith and marked as ANNEXURE - P5 (Pages 20 to 21). She is not

issued with any card till date. Annexures P1 to P5 would show that the children of the petitioners are endosulfan victims. All of them are included in the victim list prepared by the State of Kerala.

2. It is submitted that, as per G.O. (Ms) No. 07/2012/H7 FWD dated 12.01.2012, the Department of Health and Family Welfare, Government of Kerala has passed the following order:

"At present Kerala Social Security Mission is providing @ Rs.1700/assistant p.m Endosulfan bedridden victims who are getting Rs.300 as disability pension, Rs.2000/- p.m. to those who are not getting disability pension and Rs.1000/ p.m. to other Endosulan affected patients (vide GO(MS)89/2010/SWD 06.12.2010). As per the recommendations of the National Human Rights Commission read above, Government are pleased to sanction the financial assistance clubbing with that now being given by the Kerala Social Security Mission, as given below:-

- (i) Rs.5 lakh to beridden/unable to move.
  - (a) Being the first step a lump sum amount of Rs.3 Lakh (Rupees Three Lakh only) may be disbursed in two instalment of Rs.1.50 lakh each i.e. the first instalment of Rs.1.50 lakh will be given before 31<sup>st</sup> March 2012 by the Plantation Corporation

- and the second instalment by Government in next financial year after providing sufficient budget allocation for the same.
- (b) Balance Rs.2 lakh will be treated/considered as a deposit and the beneficiaries will be given a monthly assistance of Rs.2000/- p.m. for a period of 5 years equal to the return from long term deposit of the solatium amount. The deposited amount of Rs.2 lakh will be returned to them in lump after 5 years and Plantation Corporation will meet the expenditure. Thereafter no financial assistance will be continued except the disability pension already drawn by the eligible persons.
- 2)The number of beneficiaries in this category comes about 2453, Government will have a financial commitment of Rs.36.79 crore (Rs.4.50 lkh x 2453) and Plantation Corporation has to meet Rs.36.79 crore during the current financial year and Rs.49.06 core after five years on account of refund of deposit amount.
- (ii) Rs.3 lakh to other disabled persons
  - (a) The method of payment is same as mentioned above ie, the lump sum amount of Rs.2 lakh be disbursed in two instalments i.e. the first instalment of Rs.1 lakh will be given before

- 31.3.2012 by Plantation Corporation and the rest Rs.1 lakh will be disbursed by Government during next financial year after providing sufficient budget provision in this regard
- (b) Rs.1 lakh will be treated as deposit and the beneficiaries concerned will be given a monthly assistance of Rs.1000/- p/m for a period of 5 years equal to the return of the solatium amount. After 5 years Rs.1 lakh will be returned to the beneficiaries in lump and the Plantation Corporation have to meet the expenditure. No financial support will be continued after 5 years.

Since the number of beneficiaries are 1729 the Financial commitment of Government is Rs.17.29 crore and Rs.17.29 crore after five years to plantation Corporation".

The true copy of the said G.O. (Ms) No. 07/2012/H7 FWD dated 12.01.2012 issued by the Department of Health and Family Welfare, Government of Kerala is produced herewith and marked as **ANNEXURE – P6 (Pages 22 to 23)**. However, till date, the said G.O. is not implemented by the Government of Kerala completely. The petitioners and several other persons who are entitled to get Rs. 5 Lakhs as promised by the State of Kerala are yet to receive the said amount, it is pertinent to note that it was only due to the aerial use of endosulfan that the physical and mental health of the petitioner's children are affected badly and they are

- severally ill. The petitioners had to spend a huge amount of money for the treatment of their children. They are having huge amounts of debt already.
- 3. State of Kerala has already prepared a list of endosulfan victims who are entitled to get Rs. 5 lakhs as promised in Ext. P6. The petitioners are not furnished with the copy of the said list. The respondent has refused to publish the copy of the list of victims, stating that publishing the same would cause infringement of the right to privacy of the endosulfan victims. The total number of persons included in the said list would come to around 6000. There are very many persons who are entitled to be included in the list, but not included in the list. The State Government has given different numbers, when enquired about the number of victims who are entitled to get Rs. 5 lakhs, at various point of time.
- 4. As per the information received by one Sri. Muneesa Ambalathara on 28.09.2017, the number of persons included in the list of victims at present is 5209. The true copy of the communication dated 28.09.2017 obtained by one Muneesa Ambalathara under the Right to Information Act is produced herewith and marked as ANNEXURE P7 (Page 24). Though in Annexure P7 it is stated that the persons included in the list of victims prepare by the State of Kerala is only 5,209, the actual number of victims is much more than that. Thousands of children already lost their lives due to the non-availability of proper medical care. The economic backwardness of the area prevents the persons like petitioners from giving proper care to their children on time.

- Thus the disbursement of Rupees 5 lakhs to the petitioners and family of the other victims is very much essential.
- 5. This Hon'ble Court, as per order dated 10.1.2017 in W.P(C)No.213/2011 had directed the State Government "to release the entire undisbursed payment of compensation, quantified as Rs.5 lakhs each, to all the affected persons, within three months from today". It is submitted that the State of Kerala has already prepared a list of victims/persons affected by Endosulfan. The said list is not exhaustive. The State Government has to release Rs. 5 lakhs each to all affected persons. It cannot limit disbursement of the amount only to the persons included in the present list maintained by the Government of Kerala. The children of the petitioners are Endosulfan victims, but till date the petitioners have not received Rs.5 lakhs as directed by this Hon'ble Court in its order dated 10.1.2017. They are identified as Endosulfan victims. The petitioners are under acute financial difficulties. There are very many persons in the State of Kerala who are suffering from the disease caused by aerial use of The respondents are liable to disburse Rs.5 Endosulfan. lakhs to each of them, forthwith.
- 6. It would appear that despite the clear directions in the order dated 10.1.2017 in W.P(C)No.213/2011 by this Hon'ble Court the State Government has, quite wilfully, taken no steps to disburse Rs.5 lakhs to the petitioners and other victims who already find a place in the list prepared by the State of Kerala. The conduct of respondents herein show wilful disobedience of the directions of this Hon'ble Court by not

disbursing Rs. 5 lakhs to the petitioners as well as to the family of other Endosulphan victims in the State of Kerala and thereby showing disrespect of the directions of this Hon'ble Court on 10.1.2017 in W.P (C) No.213/ 2011 is nothing but the contempt of the order passed by this Hon'ble Court and a civil contempt within the meaning of Section 2(b) of the Contempt of Court Act, 1971.

- 7. It is therefore just and necessary that this Hon'ble Court may be pleased to initiate contempt proceedings against the Respondent/ alleged Contemnor herein and punish them accordingly.
- 8. It is therefore, submitted that present petition is being filed for initiating the contempt proceedings under Section 12 of the Contempt of court Act, 1971 read with Rule 3 (c) of the Rules to Regulate Proceedings for Contempt of the Supreme Court, 1975 against the Respondent/ alleged Contemnor herein.

### **PRAYER**

It is therefore, most respectfully prayed that this Hon'ble Court may be pleased:

- a) To initiate the contempt proceedings under Section 12 of the Contempt of Court Act, 1971 read with Rule 3 (c) of the Rules to Regulate Proceedings for Contempt of the Supreme Court, 1975 against the Respondent/ alleged Contemnor herein for wilful disobedience of the order dated 10.01.2017 in W.P.(C) No.213/ 2011 of this Hon'ble Court, and;
- b) To direct the Respondent/ alleged Contemnor herein to disburse Rs.5 lakh to the Petitioners and to all other families of Endosulpan victims in the State of Kerala forth with;

c) To pass such other order (s) as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case.
